You Are Not Done Yet

Accepting life as it came his way was the key to a great adventure

I came to AA in 1996 after my second DUI. Encouraged by my attorney to take an action before going to court, I immediately started attending AA meetings.

I soon became aware of just how out of control my life had become after 13 years of boozing. I got a sponsor and began working the First Step. Wow, I thought. This is exactly what my life is like--completely unmanageable. My finances were a disaster, friends were nearly non-existent, my communication with family had deteriorated to the rare holiday call and I felt trapped in the misery of an unhealthy relationship and a job I loathed.

At the same time, I was noticing that those who had been around AA for a while seemed to have order in their lives. I wanted what they had, but that would have meant quitting my job and leaving my eight-year relationship. People kept telling me not

to make any major changes in the first year. I listened, waited, and worked the program. My sponsor kept telling me, "It's a process!" I grew to hate the phrase, but he was so right!

As I put together more time, things started to become a bit more orderly. I spoke with the IRS and established a payment plan for those five years of claiming 14 dependents, I gradually reintroduced myself to my family, and I started to make friends in AA. I stayed at my job and with my partner until I was sober for one year and eight months. As a result of making meetings, working the Steps and a whole lot of prayer, something clicked at that point in my sobriety. I took everything I owned (my clothes

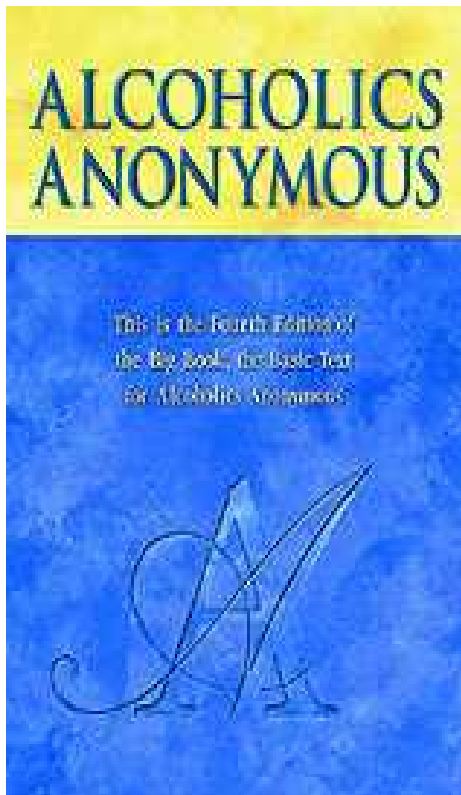
and two television sets) and left my partner. I accepted a new job that paid a salary of less than half of what I had previously been making, but with a lot less stress. The changes were scary, but I knew without doubt that they were good for my sobriety, my spirituality and my serenity. I rented a room from someone in the program for \$75 a month. I cut back and survived on peanut butter sandwiches and water, but it was okay: I was happy in my journey. I knew that as long as I did not drink and continued going to meetings, everything would be okay, no matter how bad things might seem.

The "process" continued and after six months I was recruited by another company in my new field. Suddenly I was earning the same amount of money I had made in my previous career. Within a year, I had found my own place, a small studio apartment in the heart of Washington, D.C., close to work and, more importantly, lots of meetings.

As I continued to clean up the wreckage of the past, I put a concerted effort into establishing stability in all areas of my life, and after about four years of sober time, I had my little place, my cat Chad, many dear friends, a job I loved and my sobriety.

In my daily prayer and meditation, without fail, I would ask God to continue to bring good into my life. Over the course of the next two years, I had a number of suitors, but I was happy in my little life. I had a chance to move to a bigger place, but my place was comfortable and safe. I was invited to join others for activities, but I did not want to rock the boat. My life was manageable and I intended to keep it that way.

Unmanageability is horrible, but too much manageability is the same as taking control and not letting God's will be done.

Accepting life as it came his way was the key to a great adventure

In February 2002, just after my six-year sober anniversary, my boss approached me and said she was planning on opening a new office in New York City; she said she would like me to go there and work. Of course, I immediately said, "No!" I couldn't leave my meetings, my friends or my orderly little life. She asked me to think about it over the weekend and get back to her; I agreed.

Well, needless to say, HP and I did some heavy talking that weekend. As I prayed to him to bring good into my life, he interrupted me! He said, "What do you think I have been trying to do? But you keep shutting the door on it! The suitors, the opportunities, to all of them you have said no. Do you really want me to bring good into your life, or do you want to keep this simple, overly managed little existence that you have? It is a process and you are not done yet!" Whoa, I thought, he's right!

I relocated to New York City in December 2002. I immediately started doing 90 meetings in 90 days, I got a sponsor and I got a sponsee. I made a commitment to myself and my Higher Power that I would take the first service position that came my way. One of my AA friends was in need of a co-chair for the fund-raising committee of the Big Apple Roundup. I first thought this was more than I'd asked for, but I kept my promise and said, "Sign me up!"

This service position was truly God-given; it took me to meetings all over the city, from Queens to the Bronx, even to Long Island. I got to plan sober events and to get others involved as well, especially newcomers. My process was back in motion After six months, one of my suitors from D.C., with my bless-

ing, moved to New York to be with me.

After two years as a New Yorker, hundreds of new friends and acquaintances, and a life experience beyond my wildest dreams, my partner decided city life wasn't for him. He wanted to move to Florida. I was at first disappointed, but then I remembered my prayer, and posted my resume online to see what might happen. Within six weeks, we moved to Fort Lauderdale.

Today my partner and I have a wonderful home on the water that we share with our Dalmatian and two cats. I have an incredible job. I live within a few hours of my mother and my brother's family. I have returned to college and will soon finish my bachelor's degree. I have a fantastic home group. Although my time in New York ended abruptly, it was an excellent adventure that I nearly missed out on. I made lifelong friends and found some of the best AA I have ever encountered.

The most important idea I have learned during this "process" is that a lot of good can come from change. I learned that I need to listen to my Higher Power. I learned not to fear that which God puts in my path. I learned that unmanageability is horrible, but that too much manageability is the same as taking control and not letting God's will be done.

Today, I pray to God to continue to bring good into my life. Then slowly, I open my eyes, anticipating just what exciting adventure he may have in store for me next!

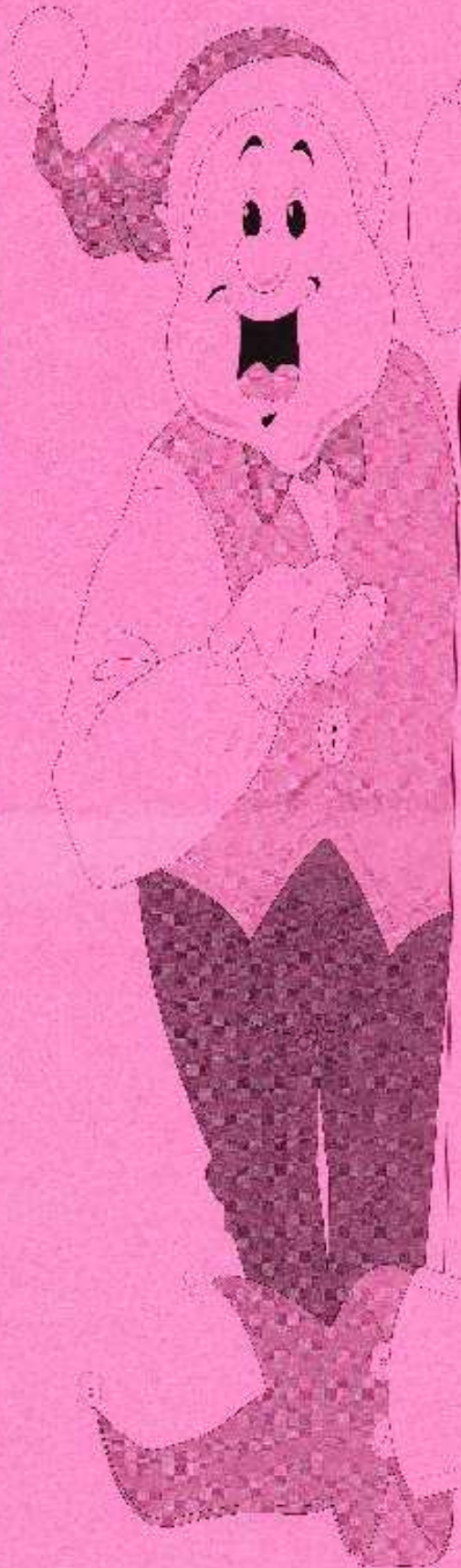
